### You have 2 Membership options:

Passing an Airspace Brief and Test is mandatory to fly at Dunstable Downs and a lifetime **Airspace Helmet Sticker** will be issued to pilots successfully passing the Airspace Briefing by the Club's Lead Coach.
- 2. Limited Membership Fee £5.00 per year.** This is for pilots who **ONLY** want to fly at Chinnor, Sharpenhoe and Holmbeck Farm, but **NOT** at Dunstable Downs. An Airspace Brief and Sticker is **NOT** required.

#### DECLARATION

1. I am a fully paid up member of the BHPA. 2. I understand that in the event of any accident or incident howsoever caused, no claim may be made by me, my estate or on my behalf against the DHPC, its committee, coaches or members, or against any landowners, and/or site operators. 3. To aid efficient distribution of Club information, the DHPC holds its membership details on a computerised database. I understand that this will include my details. I have the right to object to this by means of a written and signed letter stating such objection included with my membership application. Please note however that a member exercising the right not to have their records held on the club database risks not being fully informed of DHPC activities, changes to agreements and up to date information on sites. 4. The DHPC are required to disclose membership details to certain parties that have a legitimate requirement to have access to that information. This includes, but is not limited to landowners and / or site operators. I understand that membership of the DHPC is conditional on my agreeing to this disclosure. 5. I understand that my details may be published as part of a DHPC membership list, which will only be made available to other club members. 6.
